**FUNDS OF INVESTMENT PROJECTS  
ARE PROTECTED FROM  
SEIZURE, CONFISCATION, OR FREEZING  
EXCEPT UPON A COURT ORDER  
OR FINAL RULING**

CANNOT ISSUE  
EXTRA FINANCIAL  
PROCEDURAL CHARGES  
ON INVESTMENT PROJECTS**

**AUTHORITIES CANNOT  
CANCEL OR HALT  
THE INVESTMENT PROJECT'S  
LICENSE OR SEIZE THE LAND  
ALLOCATED FOR THE PROJECT  
EXCEPT AFTER HEARING  
AN APPEAL**

**INVESTORS HAVE THE RIGHT  
TO ESTABLISH, EXPAND,  
FINANCE FROM ABROAD,  
WITH FOREIGN CURRENCY,
